4. **Warranty of all items one month.**

Payment will be made on submission of Invoice in the name of "COMSATS University Islamabad, Wah Campus" with a copy of delivery challan (s) after the complete order has been supplied, inspected and accepted which includes delivery and installation, and COMSATS Wah acceptance / inspection thereof.
7. All prices should be quoted on F.O.R (Pak Rupees) and valid for at least 30 days.
8. In case of any dispute or grievance, the matter shall be addressed as per PPRA rules.
